

AFFIDAVIT

I, V. Ravichandran, Son of Late R. Venkataraman, Age 59 Years, Honourable secretary of the school Smrti Charitable Trust running the School, Smrti Academy, No.18, Huskur, Anekal Taluk, Bangalore - 560099 do hereby solemnly affirm and sincerely state as follows:

1. That Smrti Charitable Trust is a registered Trust under the Indian Trust Act, 1882
2. That Smrti Charitable Trust operates under the name and style of Smrti Academy and is of Non-Proprietary Character. That all permissions from the Government have been taken under the name of Smrti Academy. However, the legal entity is Smrti Charitable Trust and so all Bank Accounts are maintained under the name of Smrti Charitable Trust
3. That the school is being run as community service and as a business and that commercialization does not take place in the school in any manner whatsoever.
4. That no part of Income from the Institution is being and will be diverted to any individual in the Society/School Management committee or to any other person/entity. The saving, if any, after meeting the recurring and nonrecurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
5. That school is not paying any charges towards using name, motto, logo or any other non-academic activities.
6. That the school will not open class under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the principal and Correspondent/Honourable Secretary of the school have individually gone through the provisions contained in the affiliation & examination bye-laws and the circulars issued by the board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination bye-laws, directions issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPS, ESI and labour Laws etc. with respect to the school and staff of the school.
9. That the school will ensure that the building safety, Fire safety, Water safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed team.
10. That the school will ensure that all required infrastructure is available with the school before starting classes.
11. That the school will ensure that sufficient number of the qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classed.
12. That the school will follow the provisions related to fee contained in affiliation bye-law and will disclose the details of the fee to the students/parent every year before start of session without resorting to any hidden charges in the heads of the fee.
13. That the school will not coerce any student/parent to buy books/stationery/uniform from any particular shop.
14. That the school shall strive to make efforts for conservation of environment.
15. That the school will ensure that school fulfils all essential requirement before applying for affiliation and will fulfil all other conditions post affiliation and comply with all the general rules as given in the affiliation bye-laws notified from time to time.

16. That the school will not start CBSE pattern classes without submitting a commencement certificate to effect that the school has complied with all the conditions imposed by CBSE and post-affiliation conditions contained in affiliation by-laws along with general rule.
