Sl. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 6 (Two sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 22 of which not more than 1/3rd sections may be used for senior secondary classes. The number of students in each section shall be restricted to 40. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	The height of boundary wall is seen less than 6 feet in some area of the school. Hence the school is directed to raise the height of concrete wall upto 6 feet and submit the compliance within 3 months on SARAS portal.
3	The school has converted regular cubicles into CWSN toilets which are small and narrow and there is no room for a wheelchair/walker to navigate freely. Thus, the school is required to construct the CWSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and Board's guidelines within 03 months and submit the compliance on SARAS portal
4	The signage in the Composite lab is temporary. It is not fit for conducting experiments, as it does not have separate work stations with inbuilt utilities for bio and chemistry sections and no tables with equipment for physics section. The school shall upgrade

	the lab as per SoP issued by the Board within 3 months and submit compliance on SARAS with videography.
5	Biology lab should have more sinks. School must ensure of availability of all safety features in all the lab and submit compliance on SARAS portal within 3 months.
6	Seating arrangement in Math lab is not proper. The school shall upgrade the lab as per SoP issued by the Board within 3 months and submit compliance on SARAS with videography.
7	The school shall conduct training of its teachers with CoE Bengaluru within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
